
## NIMUN's wings soar anew!

She also reiterated the importance of their involvement and equal representation and how this could lead to promising change in the future. She then shared her perspective on the agendas the UN is working on. She was delighted to see that many of the committee agendas at NIMUN were interlinked to the goals set by the UN for 2030! She appreciated the conference's efforts to bring together the youth and start such important conversations even amidst a pandemic. This year marks the 75th anniversary of the United Nations Organization, an organization, which has been a cornerstone for multilateralism since its conception. Even though it was born from war, the United Nations today, remains for peace. New threats - such as the commercialization of space resources- have emerged, while we still contemplate over the dreadful history of the Iranian Hostage Conflict. When one war ends and becomes history, we heave a sigh of relief as we once again hope for a stable world and prosperity. Yet it has time and again been proven that the end of one war, does not mean the end of history, rather a beginning for much larger, unforeseeable challenges.

As we face the biggest global crisis since the Second World War, the Corona Virus Disease pandemic, international peacekeeping and safety seems to be in tethers. The reason for this, is not the growing instability or social unrest; nor is it due to global terrorism or a rise in popular trends such as climate change, and population growth. 

# Full frontal with Dr. Farah Usmani

**QN. YOU HAVE BEEN WITH THE UN INTERNATIONAL CIVIL SERVICE FOR OVER 15 YEARS NOW AFTER HAVING GRADUATED FROM SEVERAL ESTEEMED INSTITUTIONS LIKE THE LONDON SCHOOL OF ECONOMICS AND CORNELL UNIVERSITY. WAS THIS A PART OF A WELL-THOUGHT-OUT PLAN?**

To be honest, no not exactly. My journey of working with the UN began in Lucknow. After completing my M.D. I was practicing obstetrics and gynaecology there ; wherein I got an opportunity to work in a USAID project which dealt with development projects for young girls and women. And thus, that is where I became quite interested in public health and policy. I soon realised that to make a career out of this profession just an MD degree will not be sufficient. After consulting my USAID colleagues, I applied to the London School of Economics (LSE) and John Hopkins. I received the scholarship for studying in LSE and as part of the campus recruitment, I joined UNFPA and joined the program which focussed on women and girls at global, regional, national, and sub-national levels. My first posting was in Bangladesh, from there I moved to Nepal to work with the UN International Civil Services. Currently, I have a global position and am based in New York.



**QN. YOU HAVE VISITED OVER 50 COUNTRIES IN YOUR LIFE, HOW HAS IT INFLUENCED YOU AS AN INDIVIDUAL?**

The countries I have visited were for work. From Iraq to Somalia -all these countries are facing some kind of challenges or conflicts. Every experience in these countries was humbling and made me realize how fortunate I am for everything I have in my life. I realized how one can grumble and complain about little things when so many people in these nations don't even have the necessities in life. Travelling in these countries taught me to be grateful for the little things in life which we otherwise take for granted. Secondly, I learnt about how even though there are many differences across countries and borders, issues such as marital abuse, child marriage, women issues that plague these countries such as Niger are all-pervasive and quite common to the state (Uttar Pradesh) where I come from. Traveling across these nations has broadened my views and made me aware of the developmental issues plaguing these nations. Many development issues have been collated in the 17 UN Sustainable development goals. I would thus encourage one to travel no matter where -within one's own country or all across the world. One vision I dream about is setting up a scholarship for public health people to get opportunities to visit and explore NGOs in other nations and work together as I believe that one can achieve the SDG's only by working together. Travelling broadens your horizons. I have always encouraged my children to travel and I would like to say the same to you.



# Full frontal with Dr. Farah Usmani

**QN. SINCE THE OUTBREAK OF COVID-19, EMERGING DATA AND REPORTS FROM THOSE ON THE FRONT LINES, HAVE SHOWN THAT ALL TYPES OF VIOLENCE AGAINST WOMEN AND GIRLS, PARTICULARLY DOMESTIC VIOLENCE, HAS INTENSIFIED. WHAT SUPPORT DOES THE UN PROVIDE TO FIGHT AGAINST THIS?**

I am glad that you students have caught on such an important issue. This is really sad data for us. I am very passionate about this issue as it is one of the three transformative goals we have this year. The victims cannot phone the helplines, instead, they have to text because the perpetrator is sitting at their homes. We are facing this issue in both developed and developing countries. The UN has several strategies, which are then adapted to the context of those countries. We have helped numerous women and girls. It is not a cookie-cutter approach with every country employing the same method. In some countries, we are doing data analysis where the government has sufficient funding to advocate for this pressing issue. Our role is to advocate and share robust data to inform others about this problem and at the same time, we also deal with an implementation of projects which have large fundings. One such project is the 'Spotlight Initiative', for which the European Union has donated 500 million Euros to support countries and the NGO's in their fight against gender-based violence. These joint projects between the countries and agencies help us to set up support systems or safe spaces for these victims and are part of one of the many strategies employed by the UN to help women all across the world.



The GA on the last day was a very good idea to further test the ability of the students to think on their feet. Choice of the topic was well suited and brought out relevant discussions.



## South China Sea dispute: China adamant about its claims

The United Nations Security Council (UNSC) is primarily responsible for the maintenance of international peace and security and is the only UN organ where all Member States are obliged to comply with the Council's decisions. This year, for the NIMUN X, the committee chose the agenda as the South China Sea Conflict. The South China Sea, one of the world's busiest waterways, has bountiful and untapped sources of oil and natural gas. The committee commenced with the General Speaker's List and soon a moderated caucus was conducted, which led to China denying allegations maintaining its stand on the conflict. China, which has been building military bases on artificial islands in the area for years, said the other nations "deliberately distorts facts and international law". Brunei, Malaysia, the Philippines, contest China's claim to almost all of the South China Sea. The countries have wrangled over territory for decades but tension has steadily increased in recent years. The room heated up when Vietnam shed light on the fact that China was taken to ICJ in 2016, where it was berated for the construction of artificial islands and illegally claiming the waters of the South China Sea. A lack of willingness by the US to confront China's firm on this issue left others in a state of disbelief. The session was full of surprising instances - India wittily raised a point of information and revealed a flaw in Russia's GSL, which contradicted the agenda. Despite the international pressure, China refused to bow down and stood firm on its stand. It said that it respected boundaries and other nation's sovereignty - pointing out that it has signed border treaties with twelve bordering countries - a proof of its peaceful intentions and its willingness to resolve disputes. India and Bangladesh presented their arbitration over the Bay of Bengal as an example for South East Nations and China to follow as they felt that such a step would take the relationship between the all these countries "one step forward." The session followed an unmoderated caucus to finalize a working paper. China declined to negotiate and launched into a harangue during BLOC formation. The executive board asked the delegates to revert to a moderated caucus, wherein they discussed human trafficking and the recent pandemic outbreak. China commented, "China finds it hypocritical that countries resort to historical facts and being accused of breaching international law. Why is China being accused of breaking the law in the present day?" Fingers were pointed at China and Russia and Malaysia accused them of profiteering through harvesting COVID-19 and other countries pondered over their tactless schemes. Upon the requests of ASEAN countries to the UN for intervention, China loosened its stance and agreed to give 20% of the territory to ASEAN countries. The committee meeting was adjourned with a plethora of colloquies and a nerve-wracking feat.




# South China Sea Conflict - Reaching a solution

In the NIMUN 10, UNSC deliberated upon the Agenda of the South China Sea Conflict and China's claim of sovereignty over the sea. Day one began with the UNSC announcing themselves through the General Speaker's List, followed by establishing several agendas. The delegate of India wittily stated a flaw in the Russian Delegation's GSL, as it pointed out the inaccuracy in the point raised by Russia. The second day of the session commenced with countries tabling their views. The delegate of Malaysia believed that ASEAN countries should work together to strengthen their economy, while the delegate of China admitted to signing border treaties with 12 bordering countries so as to solve territorial and maritime issues. The committee was struck with a crisis, plummeting in China and neighbouring countries. "Millions of Muslims were relentlessly being smuggled for the purpose of human trafficking into China from the waterways from neighbouring countries including India, Malaysia, Brunei Darussalam and Vietnam." China denied the allegations, which led to the United Kingdom taunting the Chinese delegation to refer to current affairs. China found it hypocritical that countries resorted to historical facts and accused them of breaching the United Nations Convention of the Law of the Sea. To add to the crisis, a news update was introduced. An unknown witness had revealed that the "Government of Russia has been involved in human trafficking for the purpose of experimentation on Muslims for medical breakthroughs and the intentional harvest of coronavirus by Chinese and Russian authorities, 7 months later - China has potentially 0 cases and Russia has announced the first-ever vaccine, therefore raising suspicion." China labelled these "accusations" as a malicious attempt to undermine China. It rubbished the evidence produced. Malaysia taking China by horns said "it has been revealed and hence is not an accusation, therefore, China is contradicting it." The Russian Delegation was firm; refused to get into any kind of discussion on the topic- neither confirming nor denying the accusation. Malaysia, strongly accused China of profiteering through COVID-19. China combated this accusation and held firm to its stand on the issue. Malaysia -the most active nation-introduced the next motion for the discussion of possible solutions for the sea dispute. The delegate of Vietnam insisted, "A fair deal should be introduced. China cannot have a claim on 80% of the sea's resources". All nations agreed to Vietnam's point. The discussions resulted in China agreeing to give a fair share of the South China Sea resources to ASEAN countries. Thus providing a solution to resolve the South China Sea Conflict.

# Disarmament and International Security Committee



## The Artificial Intelligence Arms Race: World Leaders And Their Views

The Artificial Intelligence Arms Race: World Leaders And Their Views The Disarmament and International Security Committee [DISEC] is one of the six main committees at the United Nations General Assembly [UNGA]. It deals with issues related to disarmament, global challenges, and threats to peace that affect the international community and seeks out solutions to the challenges in the international security regime. After rigorous research on topics of international security concern, the core team came up with the agenda- The Weaponization of Artificial Intelligence and Big Data. The delegates came well prepared and had carried out in depth research on their country's stand for the given agenda. They were ready to defend their country's stand and to tackle any opposition to it. Each delegate had done thorough research and had strong opinions on the use of big data and the implications of weaponizing AI. China and the USA -the two super - powers ,were under the radar from the beginning of the session as both nations had devoted a substantial part of their country's budget for development of big data and AI. The other countries accused both China and US of data theft and cyber attacks. The delegates of both these countries strongly denied these allegations. They overpowered the committee discussion and claimed that other nations are resentful of their superiority in the AI field and are maligning them. The US being a democratic nation is mindful of respecting boundaries and sovereignty of other nations while China being a communist is not. The USA pointed fingers at the Chinese government for "Invasion of privacy and causing cyber attacks", the delegate of China was quick to rebut this attack and questioned the USA's development of autonomous weapons and their capabilities to cause destruction using AI. While discussing how much control humans can have over autonomous weapon systems, Russia and Germany presented contradictory viewpoints and were at loggerheads with one another. Russia felt "Reducing human controls would reduce human errors hence less chance of mishaps on the battleground," while Germany believed that "Machines should not be allowed to make life decisions. AI will have to be controlled by humans as it can learn and store large databases. If not checked they will have an upperhand, thus having the power to cause mass destruction." Allaying the fears of other nations, the delegate of Canada said- "Humans created artificial intelligence, thus they are more advanced than AI, machines and robots." But the big question is, are we?

AI overshadows the Crisis The delegate of Afghanistan was also a hot sensation in all committee sessions, especially those after the Executive Board introduced the committee with the crisis on the second day as it dealt with AI Qaeda: a terror group operating from Afghanistan. The crisis did ruffle a few feathers in the committee, but soon it was overshadowed by discussions on the application of Artificial Intelligence in the field of military, the potential dangers due to advancement in weaponization of AI, the consequences of overusing AI and not following the UN guidelines. It is the attraction each country has towards the development of artificial intelligence to create robots, drones, and other weapons that can be used in the military and the threats that come alongside these inventions that the delegates were more inclined to talk about and thus the crisis was resolved quickly, to get back to discussing the main agenda- weaponization of AI and big data.



# Is AI and Big Data the next revolution in international warfare?



The Disarmament and International Security Committee focuses on laying out resolutions with alliances and different motions that would be passed. The first day led to a moderated caucus with not a very fruitful discussion. The delegates were merely stating facts without addressing their country's stand on the agenda. The chairperson had to continuously urge the delegates to present motions that would be based on the agenda of the committee but in vain. The 2nd committee meeting led to a gripping debate on the potential dangers resulting from advancement of weaponization of AI; a motion proposed by Germany. The delegate of Canada brought up the topic of using robots as AI to which the delegate of Germany commented saying that the point was straying from the topic. The US then proposed a motion to discuss the crisis at hand which was passed. The crisis to be discussed was that al-Qaeda had hacked into a humanoid in the USA for 10 minutes. Some country delegates blamed the US for its poor security measures and voiced their opinions regarding security breaches leading to security concerns. Some countries offered their aid to prevent this in future. An alliance with the US might prove to be helpful in the future considering it is one of the superpowers in technology and development. The delegate of the USA associated this statement to the development of AI in its country. He proposed a resolution and suggested that instead of banning AI, the countries should invest in it and promote its growth but within the human loop of course! This resolution was agreed by countries like Mexico, Germany and Canada but said that such casualty in the AI system cannot be ignored. According to the delegate of Pakistan, Afghanistan has not maintained its allies and has violated its alliance with many countries despite having alliance with a superpower like the US, it hasn't been successful to take any fruitful measures regarding the eradication. Hence the question is- Is Afghanistan productively using its alliance or is it just for namesake?

It was agreed that no country shall be given a label based on its terrorist activities as that is a matter of branding the entire nation. It was noticed that the meeting was straying from its topic repeatedly but yet, resulted in lively discussions at a later stage. Amidst this discussion, there was a new update, that the US had been developing technologies that had been banned in the meeting of the CCW (Convention on certain conventional weapons). NATO (North Atlantic Treaty Organization) intermediated the issue and wanted to hold a meeting with the countries for the preparation and response to the smuggling and manipulation of US technology and data. A motion was passed to continue with the current discussion with the inclusion of the new update. After this, a resolution is yet to be made regarding the international ban of the autonomous military but most of the countries seem to be in favour. A question viable to ask is "Will AI and Big data soon take over the world and pose a threat to humanity or is it a boon in disguise? The answer remains undecided for now but not for forever...

## Realizing the digital promise -the bumps and the pitfalls.

The first two days for the Economic and Finance Affairs Council passed smoothly with the delegates discussing and debating on their agenda, “The need for universal financial access”.


The session began with a light discussion between the delegates and the chairs. Post it motions were raised by Russia, China, Netherlands and finally Kenya.

Russia raised the motion “Usefulness of digital finance” while Germany raised “Lack of identification for refugees in digital finance”. Russia stated that digital finance and financial inclusion has several benefits to financial services users, digital finance providers, governments and the economy; notwithstanding, a number of issues still persist which if addressed can make digital finance work better for individuals, businesses and governments. While Germany looked at the humanitarian aspect of digital finance and advocated that the core essence of financial inclusion lies in its non-discriminatory principle that everyone, everywhere, should have access to essential financial services that are affordable and that meet their needs-hence provisions should be made to address the needs of the refugees. The delegates continued to debate enthusiastically on the motion and the votes were passed. China and Russia debated against the motion and pointed out the flaws of the motion. They felt that the motion has failed to address the issues of hacking, risks for consumers in Digital Finance and the big problem of identification of the refugees for their inclusion in this sector as most of them have low literacy levels.

Furthermore Columbia announced their 37% exposure to digital finance, at which the committee moved to the un-moderated caucus after surprisingly having discussed large aspects only of the sponsors and the signatories. Australia's proposal to form a unanimous bloc marked the end of the discussions for the day.

Proceeding to the second day for the ECOFIN committee commenced with motions being raised by Russia, Ethiopia, India, China and Indonesia. These were passed by the moderated caucus, though eventually all the motions failed.

Finally the motion raised by Germany was passed. Australia's continual disruption of the session forced the chair to reprimand it. It was asked by the chair to refer to the hand book. Later in the session, the delegates discussed the steps taken by their government to support the agenda of The need for universal financial access. The day concluded with discussions of the working paper and formation of one block by the delegates from Australia and Germany.

The topic of access to finance and financial inclusion has been of growing interest throughout the world, particularly in emerging and developing economies. The policy makers are also concerned with the potential negative consequences for macro stability when financial system assets are concentrated in relatively few individuals, firms, or sectors. With G20 nations increasingly focused on helping more low-income people participate in the financial system, the Bill & Melinda Gates Foundation, the Better than Cash Alliance, and the World Bank Development Research Group have partnered to highlight the exciting potential of digital payments so as to ensure financial inclusion. It is a well known fact that it is cheaper to send and to receive money digitally than it is to send liquid cash - both for individuals as well as for the government as it reduces the overhead costs of social transfer programs. Digital payments are safer; and help in reducing corruption spurring further innovation in this space and paving the way for more involvement by private sector actors and the international community. The challenges are immense. Just the existence of a digital payments infrastructure doesn't necessarily mean that people will choose to use it. Those who have never had a bank account not only need to be educated on how to use one but also have to be made aware of their safety and reliability. This will ensure that they use digital accounts to build credit history, save, and make financial plans not just to transfer money. The investigation finds clear evidence that addressing these significant challenges is well worthwhile -- for economies of all sizes, for governments, and for millions of people not included in the financial system -- especially women and children. According to UNICEF, the earlier children come into contact with financial service providers, the earlier they can recognize the role such institutions play in society. Germany and Australia despite their bilateral relationships and even some really pleasant trade relations ultimately landed in a heated discussion wherein Australia seemed to sidestep from the point of focus. However the committee being excessively focussed on the agenda - made a unanimous block with only one or two objections which were also approved finally. The resolution which was under construction found Australia and Germany as its two of the four sponsors on the very first day itself. After intense discussions and arguments, the crisis was scrutinised thoroughly and updated in the following session after an UNMOD criticized it for illicit transactions rather than support it for its contribution to the financial sector. After intense discussion about the crisis and the updates the committee entered an UNMOD followed by the drafting of the resolutions. Since it was a unanimous block, the working papers were sponsored by : Australia, Kenya, Germany and China and all others as the signatories. Hope the global community works together collectively to come up with solutions to ensure Financial inclusion for financial access to all.

## A Day Of Discussions And Deliberations

On the first day of NIMUN 10, the Special Political and Decolonization Committee discussed the agenda “Promoting sustainable foreign investment in the formerly colonised states”. The proceedings for the day commenced with several motions being raised by the delegates of Germany, Burkina Faso, Jordan, USA and the French Republic. An extremely pertinent motion was raised by the delegate of Jordan about the economic losses faced by formerly colonized countries. This led to a quite fruitful discussion surrounding the importance of the effect and aftermath colonization has on the economies of ex- colonies. During the stages of colonization, the native people of these nations had little to no influence on the way their own country was run. The outcome of this was that the people of the newly independent nation had very inadequate knowledge on how to keep the nation-state going and left them struggling with challenges of leading their nations whose economy was completely gutted and destroyed by colonisers. Colonialism left the independent nation unprepared to function in the modern global nation-state system and vulnerable to outside influence and pressure.

The delegates of colonised nations felt that sustainable Foreign direct investment will help in creation of higher skilled jobs, the introduction of technology and innovation and improved access to international markets. Keeping this sentiment in mind the delegate of Pakistan then raised a motion regarding the relevance of foreign direct investment for sustainable development. A point stated by the delegate of Germany about the importance of efficient and optimum use of funds provoked quite a discussion about the importance of FDIs for sustainable development.

There were also several motions raised by the delegates of Spain, China, Egypt and Norway. A motion by the delegate of Norway, concerning the impact of regional integration on economic activity was passed.

It was an extremely successful day, filled with heated debates. The delegates were also quite energetic and attentive throughout the session.

# Rethinking support measures for the less developed countries.

The discussion by the members of SPECPOL committee was about ways to promote sustainable investment in the formerly colonised states.

It is reasonably evident that colonialism has had a long lasting impact on ex- colonies. Colonialism drew economic development in some countries and economic decline in the others. The delegate of China, during the drafting of a working paper, recommended the betterment of infrastructure in the LDCs to improve trade and commerce which would most definitely result in the growth in their economy. The delegate of Niger, on the other hand, advocated the reinforcement of security in the bordering countries in order to promote foreign direct investments. The delegate also mentioned that Niger, in spite of being a peaceful and politically stable nation, is unable to attract foreign investors due to "border insecurities". It is critical that countries with a fairly good and well-established economy sustain and increase their presence and participation in this important international forum and help the LDCs when in need. The delegate of Germany mentioned the several measures that were incorporated by the nation to promote FDI in the LDCs. The delegate of China, likewise, discussed the country's recent provision of aid to build 70 per cent of the roads in the town of Gwanda , Zimbabwe, geared towards "building relationships with the 'nearby' countries". Xinhua News Agency Reporter to the Delegate of China, SPECPOL: China is one of the world's largest economies. Do you think the fluctuations in China's economy matter for the LDCs?

The delegate's reply: "Yes, for sure. China invests in a number of countries and if it thinks it's going through recession, China would definitely delay or stop some part of the financial aid going out of the country so that it can run itself completely okay" An unanticipated crisis hurtled highlighting an immense recession in Germany's economy due to which the country had decided to marginally curtail the financial aid that it used to provide other countries. Countries such as Pakistan, Iraq and Bangladesh which are heavily reliant on aids from Germany were deeply affected. The delegate of Germany responded to the crisis with an apology and simply asked for "time to reach its recovery state". "The economy of Bangladesh is highly dependent on Foreign Direct Investment. If it doesn't receive aid from Germany, the economy of Bangladesh may collapse" the delegate of Bangladesh stated. The delegate of Iraq, contrary to the delegate of Bangladesh, confronted Germany for not being able to provide aid and for making false promises. " That's nothing but selfish. That's simply and particularly in all words, selfish" said the delegate of Iraq in response to the delegate of Norway's assertion about leading their nation to a self-sufficient state before granting aid to the LDCs. The delegates debated upon various subject matters and came up with very innovative proposals to provide help to the LDCs. With truthful and genuine economic and social support from the more developed countries, LDCs could unquestionably enhance their participation in the world economy and gain access to more opportunities. All this and more seemed to envelope the atmosphere in the SPECPOL committee and led to defining the session as a 'rousing and discerning' one.

The committee for Day 1 began with the Agenda "The impact of the Iranian Hostage crisis on the latter half of the 20th century". The delegate of the United States along with the delegate of Iran began a heated debate discussing the USA's accountability of being involved in a war between countries that it supports. Further in the session, the Delegate of Israel raised a motion to discuss the ongoing Gulf war that took place in 2003 between the United States and the country of Iraq which passed by the majority voting. Instead of presenting the views of the USA, the delegate chose to reply to the accusations made by the delegates of Iraq and Iran. This later led to a fiery debate between the Delegate of the United States and Delegate of Iraq, which led to the delegate of USA to ask the chairperson to debar the delegate of Iraq from the committee proceedings due to his offensive remarks. The arguments of the USA's delegate was supported by the delegate of Kuwait.

The delegate of Iraq was called out by the delegate of the USA regarding being held accountable for committing humanitarian crimes and killing in Kuwait by the utilisation of nuclear weapons which was against the policies and acts of the president Saddam Hussain. # Iranian Hostage Crisis - Has it really calmed down?



The Iranian Hostage Crisis conflict changed the course of American History. It was the culmination of several decades of bad blood between the United States of America and Iran.

On Day 1 of the committee, Iran and the USA's heated arguments kept the air buzzing. "If the US crimes against Iran were shown to the world, it would make a large book," said the delegate of Iran. The delegates of Iran and the USA protected their country's stance -arguing fiercely and not yielding ground to one another. Iran accused the US of providing weapons to Saddam Hussain -the accusation which the US strongly denied and claimed it to be false . Reiterating its country's stand it said, 'The USA never acted, enacted or had any kind of participation with the Iran Iraq war.' The delegate requested an apology from Iran for its unwarranted accusations.

Next the moderated caucus regarding the "ongoing gulf war" took place wherein as the chair had to step in to take the place of the Delegate of Kuwait as Kuwait was absent. The Chair states " During the Iran and Iraq war, Iraq received funding (2-3 billion dollars) from many countries- Iraq was unable to give the money back. Iraq pleaded for exemption citing its poor economy as the reason for its inability to pay back-the other nations refused to give a ropeway to Iraq. The country saw the conflict as an opportunity to invade Kuwait ;take over the oil mills and earn money by selling oil-pay back its lending nations

The shocking mid-Committee conflict and the two news updat about france's role in spread of COVID -19 put the delegates of the United States of America and France on a backfoot. An apologetic France said " It was unintentional to spread the virus, however, the French government is apologetic and is willing to help nations as needed, also it was wrong to call it an act of terrorism ". On the other hand, the USA claimed it to be false news and said, ' The USA is in a dilemma why it is being condemned and held responsible for the spread of spread of the virus in Iraq'. Furthermore, the Delegate of the USA in his resolution mentioned the democratical judicial process would be taken against the scientist responsible for 17,000 deaths. Iran immediately reverted to USA's statement and said: "When Iran asked for the Shah after 26 years of constant torture and cruelty on its citizens, why did the USA not return the Shah?" The United States retorted "The Shah that you are mentioning was told by your people and government to go away, therefore the Shah escaped. It was not just the United States of America but also the country of Egypt, The Shah is buried in Cairo because that was his last resting place". The delegate further stated "The delegate of Iran's position is only focusing on the United States and not Egypt? This is absolutely bilateral that Iran is taking their benefit" " Offering Asylum to the monarch of Iran, Egypt was just showing some humanity to the monarch of Iran" said Egypt. The Iranian Hostage Crisis though long over still cast its shadow on the discussions with the nations showing little faith and trust in one another's actions.





## The Race For Space

The agenda for the first committee session of UNOOSA was 'the commercialization of space-regulation, the exploration, exploitation and utilization of space resources'. Nations such as the USA and Indonesia were in support of advancing the growth of space exploration and commercialization, DPRK was partly in support of this idea but cautioned against using the private sector firms for this purpose, due to their capitalist nature wherein their primary goal will be to turn a profit. DPRK pointed out that the exploration and use of space should be for the benefit of all humanity and for peace, security and development. The delegate of the UK pointed out the need for collaboration amongst all the nations for space exploration due to its exorbitant cost as it is a technologically intensive as well as labour intensive endeavour. Most countries favoured the UK's request for collaboration and to have joint space programs. However, countries like Malaysia and France cautioned the nations in their race for space. They wanted the nations to first assess the environmental impact due to increase in space exploration. They advocated setting up regulations-abiding on all - before the nations began their quest for space exploration and for the utilization of space resources and cautioned against privatization of space. On the second day of NIMUN X, the delegates of UNOOSA brought up very rational arguments regarding their countries and were primarily focused on the issue of "privatization of space". The committee proceedings took off from where they left off from the previous day. During the course of a few moderated caucuses raised by the delegates, a few major developments were made. Later, the committee had an unmoderated caucus where all the delegates started writing up the drafts of their working papers. The session ended with a discussion of their working papers as they will be important for laying the foundation of the draft resolution.

# Nations agree -Sustainable development of Space must


## Covid -19 casts its shadow on the discussions

The delegates from the UNOOSA committee discussed the actions of Russia and that inevitably led to a crisis. The delegate of the USA proposed that countries should help nations that have been severely affected by COVID-19. The USA also supported Russia and said that 'things like this are bound to happen and we need regulation to provide proper safety'. Japan demanded compensation from Russia as it blamed it for the crisis. In order to pressurise Russia and to find support for its compensation Japan went out of its way to create a board with other countries for establishing proper security procedures. The delegate of the UK agreed with Japan's plan to form a board as the UK felt that Russia's actions were reckless. Under the pressure from multiple nations Russia said that it will give compensation after the COVID-19 pandemic. However, the delegate of UAE was not happy with this plan and said that a late compensation given is unacceptable -Russia needs to take immediate action and clean up the mess they made-satellites should be relaunched. Algeria supported the UAE stand and said that under the UN treatise Russia is bound to compensate.

The delegate of Malaysia found it ironically that all the delegates were sitting and blaming Russia; asking it to pay compensation instead of trying to come to a solution and chipping in money. Malaysia suggested removing the space debris using a laser. Germany believed that it was not fair to ask Russia to pay the compensation instead regulations should be laid down for conducting tests to avoid such a situation in future.

Russia welcomed this gesture of Germany and claimed that the Russian space agency works professionally and cannot be blamed for accidents during a launch. It proposed to form a supervisory body to oversee the removal of space debris by bringing them back to Earth. The UK, skeptical of Russia's plan, felt that the plan was not good. Russia promised to provide use of its satellites to other countries during this global pandemic.

As a result, the topic shifted from the Russian crisis, to the topic of space commercialization and the main agenda of the committee session. Japan was concerned about the negative environmental impacts of bringing back large amounts of space debris. Most countries were committed to expand their space program in order to gain access to space resources, UAE proposed fair distribution of these resources. The delegate of France proposed involvement of Private companies should work in tandem with Government agencies for space exploration so as to make it cost effective. Japan supported France as it believed that without the research and support of private firms the world wouldn't have reached where it was. The delegate of UAE too acknowledged the crucial role played by private companies in fostering the space economy. However, nations like DPRK and India were not in support of commercialization of space as they felt involving private agencies will have a negative impact on environmental impact as they are driven by their desire to make a profit. The agenda of the commercialization of space- regulating, the exploration, exploitation and utilization of space resources, was greatly discussed in this committee. Some countries see eye to eye on certain issues and some don't. Is space exploration a viable idea? Is commercializing space a good idea? Only time will tell.

## Xinhua Targeted for not voicing its population; TASS faces criticism for unobjective presentation- Al Jazeera accused for bias reporting

The International Press Corps commenced their third day of the Navrachana International Model United Nations, by launching a formal committee proceeding, after its delegates spent the last two days reporting on the occurrences in other committee sessions. The Chairperson, Diya Rajgor, and Co-Chairperson, Hetvi Chaniyara, began with the roll call, to mark the presence of the delegates in the committee. Due to the pandemic, and the necessity to adhere to guidelines, this session took place online, using zoom meetings.

The agenda at hand, was to "Discuss how the media throws light upon the various global issues at hand owing to the gravity of the situation considering the role of ethics in journalism." This agenda aimed to throw light on the value of ethics and right reporting of news and information during the Covid Crisis, and further to raise awareness of unethical practices and the spreading of fake news by media agencies, during the pandemic.

The committee proceedings commenced with the motion raised by the delegate of Telam Argentina, after which the General Speakers' List was established when the delegate of United Press International, Reporter A, raised the motion to do the same. The GSL contained globally recognised agencies such as TASS Russian News Agency, United Press International, and the Australian Broadcasting Corporation. In the GSL, Agencies mainly focused on the ways in which their media has been influencing the pandemic, and adhering to ethical and right journalism. Soon, a moderated caucus was launched, by the United Press International- Reporter B, to discuss "Media Coverage during Covid 19 pandemic". This topic was passed under the chair's discretion, due to the necessity for the discussion and raising awareness as well as connecting ethical journalism to the pandemic. The discussion saw Xinhua News Agency, TASS Russian News Agency, as well as Associated Press Pakistan, among others participating to present their stance on the media coverage. In this caucus, Telam Argentina accused Xinhua News Agency for reporting and stating false statistics in their news report, to which Xinhua News Agency had a subtle response, stating that they wish to promote stability among the population in their country.



### Recession & Retrenchment




# Editor Afterword



## The Press team reflects


